PRICES

All prices shown are in U.S. Dollars. Prices are subject to change without notice and will be confirmed at the time of order entry. For the bulk, custom-synthesis and special order items, the written quotation is guaranteed for 30 days. In addition, a shipping and handling charge will be added to the invoice. Chemcia Scientific, LLC (Seller) accepts the Buyer's express carrier (such as FedEx) account for shipping. The handling fee is \$15.00 for each domestic order, and \$20.00 for each international order. For the international sale, certain bank-related charge will be also added to the invoice.

DELIVERY AND PAYMENT

Seller normally uses FedEx for delivery unless certain items are restricted by D.O.T. and I.A.T.A. regulations that require those to be shipped with special packaging and truck transportation. Due to special handling, certain products sold impose an additional packaging fee and/or a handling fee which will be added to each invoice. Terms of sales are net 30 days of date of invoice. Immediately upon Buyer's receipt of the shipment, Buyer should fully inspect those received, notify Seller in writing of any claims for shortages, defects or damages and hold the goods for Seller's written disposition. If Buyer fails to do so within 10 days after the goods have been received, such goods will conclusively be deemed to conform to the terms and conditions.

RETURN SHIPMENT AND ORDER CANCELLATION

Seller will not accept return shipments without prior authorization and shipping instructions. Charges will be imposed on products returned due to Buyer's error. In no event seller will be liable for incidental or consequential damages of shipments. Once orders are processed to the shipment stage, no change or cancellation can be granted. Bulk, custom-synthesis or special order items are non-cancellable.
